Cetaphil eReceipt Upload Program

PROGRAM TERMS AND CONDITIONS

- **1. Eligibility:** Cetaphil eReceipt Upload Program (the "Program") is open to legal residents of the fifty (50) United States (including D.C.), eighteen (18) years old or older at the time of entry. Employees of Galderma Laboratories, L.P. (Sponsor), OnCard Marketing, Inc. ("RevTrax"), Merkle Inc., and their parent and affiliate companies, as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee, are not eligible. Void where prohibited. Participation constitutes participant's full and unconditional agreement to these Program Terms and Conditions.
- **2. Timing:** Program begins on December 7, 2023 at 8:00 a.m. Eastern Time ("ET") and ends on January 7, 2024 at 11:59 p.m. ET (the "Program Period"). Servers of Sponsor and RevTrax are the official time-keeping devices for the Program.
- 3. How to Participate: Participants must make a purchase of an Eligible Cetaphil Product (defined below) from December 2, 2023 through the end of Program Period ("Eligible Cetaphil Purchase") and take the actions listed below to claim a \$3 PayPal payment (the "Reward"). Participant must use their mobile phone to complete these requirements. Accordingly, Msg & Data rates may apply. Participant must also have a valid U.S. PayPal account that is connected to the mobile phone used to receive the Reward. PayPal Accounts are free, but subject to the PayPal User Agreement.

Eligible Cetaphil Products: All Cetaphil products are eligible, except baby products, Sheer Mineral Sunscreen products, Cleansing Bars and the 4oz or smaller size of Daily Facial Cleanser, Gentle Skin Cleanser, Moisturizing Lotion and Moisturizing Cream.

Participant must take a clear and legible photo of the receipt that displays: the purchase date and time, the retailer, the Eligible Cetaphil Product, the price of the Eligible Cetaphil Product and total amount spent. Receipt image must not be larger than 10 MB and may only be one of the following file types: .gif, .png, or .jpg.
- d) The review process can take to 2-3 days. Participants will receive a text message confirming that the receipt has been reviewed and approved or alternatively, a text message explaining the reason for rejection. Participants may upload the receipt again through the end of the Promotion Period to cure the issues identified.

The Reward: If Administrator approves the receipt, a text message will direct the participant to a site to immediately claim the \$3 PayPal Reward by signing into their PayPal account. If the participant does not have a PayPal account they will receive an email with directions to create an account within 30 days to receive the Reward.
